The U.S. Bankruptcy Court seeks a self-starter to design, develop, implement, and maintain automated and technological enhancements throughout the Court. Duties include: performs systems analysis of processes to determine software enhancements/solutions to improve efficiency and productivity through automation; determines and clarifies software and automation requirements; advises on potential technical solutions to operational problems; designs, develops, tests, and implements custom software solutions; manages and maintains the software throughout its life cycle; supports, maintains and updates existing court developed software; installs or assists in installing new/revised releases of national software systems; develops enhancements to national systems; designs and develops independent applications to enhance national products; assists in leading other automation staff in developing new systems; designs and develops programs and applications on Linux systems to routinely search data in the Court's automated case management system, and provide automated data extracts, reports and e-mail alerts; develops written instructions for IT staff to support products, and for installation/implementation of products developed in-house; develops written instructions for users on features and use of the products; and designs, develops, and implements custom applications to make specific court data available on the Internet/Intranet. Performs other job-related duties as assigned.

**Qualification Requirements**

- 2+ years of full-time (or equivalent) progressively responsible experience related to the technical aspects of data processing, office automation, and data communications and their applications, terminology and methodology, including the accomplishment of computer project assignments that involved systems analysis, design, programming, implementation, integration, and management.
- Good knowledge of database structures and design, application design and development life cycle, and effective documentation and systems testing practices.
- Broad knowledge of Linux operating system.
- Familiarity with database systems (e.g., Informix, Oracle, MySQL).
- Experience in Perl, Linux Shell, Java, HTML, PHP and SQL is preferred.

- Ability to learn new technologies and problem solve.
- Knowledge of concepts of change management and demonstrate the ability to apply these concepts to managing code changes.
