CERTIFICATION

I, Michael Croteau, am a supervising forensic scientist with the Washington State Patrol Crime Laboratory in Marysville, Washington. I supervise the DNA section in the Marysville Laboratory and have been with the Washington State Patrol Crime Laboratory for nineteen years. I have previously provided two affidavits to the State to explain the capabilities of our lab with respect to DNA testing. This affidavit is provided to further clarify the previous affidavits.

While the Crime Lab does not do mini-STR or mitochondrial analysis, the STR testing that we do is capable of testing what is variously called "touch DNA" and/ or "handling DNA". STR testing will pick up DNA deposited as skin cells or cells accompanying sweat, if it is present in sufficient quantities. We have been doing STR testing since approximately 2000 so have had the technical ability to do the "touch DNA" since that time. There are subsets of the STR technique, often called "Low Copy Number DNA typing" which involve amplifying a sample more than the standard number of cycles associated with standard STR typing. These techniques are not currently being done in the Washington State Patrol Crime

Laboratory system. These techniques provide greater sensitivity, but less accuracy, than standard STR techniques.

While mini-STR or mitochondrial testing is more likely to provide a DNA result from an object that has been handled briefly, neither is currently searchable against the convicted felon portion of the databank, and are not currently performed by the Washington State Patrol Crime Laboratory.

When dealing with "touch DNA" testing, any method utilized will almost certainly consume or destroy the sample. For purposes of selecting any item for testing, it remains important to be as certain as possible that the particular item is actually related to the crime and is unlikely to have been handled by anyone except the perpetrator.
