

Dear Counsel:

As you are undoubtedly aware, as disclosed by the FBI in September 2005, and reported since in the media, the FBI no longer performs the comparative examination of bullet lead. As I worked last night, I read for the first time the portion of the report of proceedings in which testimony was introduced at the trial of Mr. Stenson concerning bullet lead analysis. Today, I faxed copies of that testimony for the FBI to review and determine the appropriateness of that testimony. The review will be conducted early next week and I will have an oral report no later than 1 p.m. on Tuesday, December 2nd. I will contact you immediately thereafter to provide the results of that review.
