#### **Executive Director – Arizona Police Association (2001-2004/2008- current)**

Operating as Chief Executive Officer my duties include:

**Assistant Director – Arizona Registrar of Contractors (2004-2008)**

My duties for this state agency were widely diverse. I served as the Chief of Special Investigations, Chief of Investigations, Assistant Director of Intergovernmental Relations, Assistant Director of Human Resources, Assistant Director Media Relations, and COOP (disaster preparedness) Coordinator. I also served as the agency's legislative liaison.

**Police Officer – City of Phoenix (1986-2000)**

My duties were varied and included assignments in investigations, professional standards, planning and research, motorcycle traffic enforcement and patrol. I also served as a Field Training Officer for new recruits.

While working in the Professional Standards Bureau of Phoenix P.D. I was tasked with building a new disciplinary system for the department. Working with department management and labor groups the system was developed and presented to the department in 2000. The system was adopted and is still in use today (many modifications have occurred since the development of the initial model).
