Reason for a stay on his execution.

Rick has had a hard life. Beginning his life, he was one month premature, was in an incubator for two weeks. Day Old had disease, he would get worse than other children. At around 7 years, on a family sliding hill he struck a board coming down, and split his forehead wide open, over a deep stitelo. Dr. J. H. H. he contracted meningitis, was bed ridden, quarantined for 6 weeks. One week after his 15th birthday clearing at a potato warehouse, he got his arm mangled in a cull belt. Mrs. said he would have a lifeless hand hanging. He worked at it and overcame a week stay in a full Sub City hospital. He saved his ^{own} arm!

A tremendous amount of trauma through his life. Rick was a young child. Had more dexterity in a finger than most have in three. Gosh babies. He was active, but nothing I figured was out of the ordinary. He was a hard worker, liked people, people liked him. He was sometimes good, sometimes bad. I never would have imagined him being convicted of this crime!

Since being paroled Rick has made many friends and respect from guards and inmates alike. He especially likes it when he is allowed to have a job. He is fantastic with art work and poetry. He is very religious

on the inside. He knows his bill inside and out.

While Rick was growing up, family was what life was. We did everything as a family. Rick was passionate about his responsibility towards his siblings and us. He was a good brother, son and friend. Always helping others. Not a perfect person, normal arguments, but nothing physical.

The family through all of this tragedy have stood with Rick; he is family. We visit him as often as we can. Talk with him many times a month. We love Rick, miss him, need him. Since his incarceration, he has always tried to impress on his siblings and sons the right way to go.



I ask you one more time for the opportunity to let me have a closer relationship with my dad, and to please grant him clemency. Thank you for your time and consideration in this very important and life changing and perhaps life-ending decision.

he was there, even in the hospital for the

people move, getting them un stuck, going
to get them if their car broke down, he always
was the first to be there. He was always
trying to help someone. I guess that's what
got him where he is today just trying
to help.

My name is Mary K. Caldwell. I worked for the Depart. of Corrections from July 87, until I retired at the end of 2010.

I first met Richard Leavitt in 1988, when my name was LelibrIDGE and I went to work in Unit 8, (Death Row) Cq Sq.

I worked deathrow for approximately 1 year in unit 8. I spoke very often to these offenders, including Leavitt. During this time I personally never had any kind of problem with him. He was always respectful, and polite. We would often talk, mostly just general topics. I did learn that he wrote poetry and had won some awards for them.

Then in 89 we opened IMSI, (Max). In 1991 I was the Corporal in B blk. again, with the deathrow inmates. Mr. Leavitt was again always polite and respectful.

As an officer, you are not suppose to consider inmates as anything but inmates, and believe me, at no time ever were any lines crossed in anyway. But, it is difficult to work with these inmates and not get to know them, and possibly ~~to~~ ^{see} them at their worse.

What Richard Leavitt was convicted of, is horrible, and I do believe in the Scott penalty, but on his behalf I will say, as far as you can say "model inmate", I would have to say he was one.

I personally never saw Mr. Leavitt
act out, be disrespectful or personally
cause an officer a problem or put any
officer in danger or harm.

I am recently retired from the Idaho National Laboratory after 35 years involved in operation of and training personnel at nuclear facilities in the US and around the world.

I met the Leavitt family in 1970. I shared many hunting and fishing trips with the Leavitt family. Boyd and Marg were also members of the Eagles lodge as were my wife and I. We spent many hours working together on and attending various functions and activities for charitable causes. At the time Boyd worked at body shop and was hard working family man.

We interacted with Rick as he was growing up at various family and Eagle events and activities. He seemed to be a normal active boy. In high school Rick had some scraps with the law and as happens in small towns the police would seem to target him when investigating any crime that took place within Bingham County. When Rick was arrested for the murder Boyd and Marg pored everything they owned into his defense. They had to sell their house and summer home in Island Park to pay for the expenses. After Rick was convicted they could not stay in their hometown and moved to Nevada where Boyd got work at a mine and continued to work to pay for Ricks continuous defense and appeals.

At the present time Boyd and Marg have moved back to Blackfoot and are both in ill health. They have just recently lost their eldest son. It is obvious to me that the execution of Rick will actually result in the in the death of his parents as they will not be able to tolerate the loss of another son in their present condition.

I am, in fact, a staunch advocate of the death penalty but only when there is absolutely no doubt in the guilt of the defendant. In at least one time in the appeal process there was some doubt raised so the guilt does not appear to be absolute. After all this time and considering the consequences this execution seems to be more about revenge than it is about justice. By eliminating the execution, in this case it is possible to let Boyd and Marg live out their remaining lives in peace and with Rick still in prison justice will still be served.

My name is Claudia Betz I am 61yrs old. I am employed at Nonpareil Corp. I have worked for the accounting department since 1985.

I have known the Leavett family since I was about five years old. Boyd and Marge are very respectable hard working and very loving people. Right now both of them are in very bad health.

I don't think either one of them will be able to handle an execution physically or mentally. The last twenty eight years have been extremely hard on them. And losing their eldest son a few years ago. Has made things even worse.

I have known Ricky since he was born. He was always respectful and extremely nice to me. He was an active and mischievous child.

I do not believe anyone should be executed if there is a chance they might be innocent. I truly believe there is a chance Ricky could be innocent. Blackfoot is a very small town. I don't think the Blackfoot Police department is equipped to investigate this type of crime.

I am asking you to please consider taking Ricky off death row. To many innocent people have been executed. Please don't make the same mistake.
