5. A RESPONSE TO PETITIONER'S VERIFIED PETITION FOR A PEREMPTORY WRIT OF MANDAMUS with attachments was filed by counsel for Respondents on May 31, 2012.


This Court being fully advised; therefore, good cause appearing,
