Patient is a single, white, 20-year-old male, who came in on a Voluntary status. Social Worker from Idaho Falls brought him. Don states he has been drinking a lot of alcohol to prove he could drink as much as anyone else. He found out he could not and it was making him ill and depressed. Patient has tried to get away from the drinking, but he has been unable to do so. He had a shotgun loaded and pointed at his throat, but he could not reach the trigger and did not pull the trigger. He lives with foster parents. He has a G.E.D., but has been doing odd jobs and working in the forest. He had a girlfriend, but they broke up three or four days ago because of his drinking. Don has used illegal drugs in the past. He likes his foster parents and wants to return to Salmon, as he enjoys hunting and fishing. He accepts the Hospital and desires to get over his depression.

Mental Status: Patient's perception is clear. He is oriented in three spheres. Memory is intact for remote and recent events. He does not have hallucinations and there is no evidence of a thought disorder present. Mood is somewhat down, but there is no psychomotor retardation. He dislikes the depression and wants to avoid it. He has no plans for the future, but might consider some vocational training. Affect is good, and he relates well at times to be fairly well at ease. He is a tall, thin youth, who weighs about 170 lbs. His clothing is clean.

ADMITTING DIAGNOSIS:

- Axial I: Substance abuse (mainly alcohol at present) with depression and suicidal thoughts.
 II: Dependent personality.
 III: Underweight.
 IV: Code 4 - fair.
 V: Code 4 - fair.

Treatment Recommendations:

1. Observation.
2. Minnesota Multiphasic Personality Inventory.

IDENTIFYING INFORMATION:

Mr. Cook is a 20-year-old, white, single male, who was admitted to State Hospital South on 11 December 1981 on a Voluntary admission from Lemhi County. On admission, Mr. Cook appeared mildly depressed; however, was talkative, open and quite conversant. Information which he gave is considered to be credible.

NATURE OF THE PROBLEM:

Mr. Cook states that he had been drinking quite heavily the past few days prior to his admission and that the excessive use of alcohol had made him become quite depressed. During this period of time he also broke up with a girlfriend and this apparently also added some to the feelings of depression. The breakup was apparently also a result of his alcohol abuse. Just prior to his hospitalization, Mr. Cook had been making suicidal threats and apparently did place a loaded shotgun at his throat; however, he states he could not reach the trigger, so did not pull it. His foster mother stated that she felt Mr. Cook was trying to gain attention and that he really was not suicidal and really did not require hospitalization.

Mr. Cook verbalizes an understanding of the difficulties that bring him into the Hospital and verbalizes the need to change his life around. However, it does not seem apparent that he has much insight, nor that he has a great deal of motivation to bring about these changes. He seems to feel that the Hospital will provide a certain amount of structure, which, perhaps, will be motivational to him and guide him in making some of these changes. Prior to his hospitalization, he had seen Gary Payne, Psychologist in Idaho Falls, and, also, had been working with Larry Muse, Mental Health worker in Salmon.

BACKGROUND:

Mr. Cook was born on 23 July 1961 in Cooke County, Illinois, to Gordon Wayne Cook and Wanda Dunn Cook. Mr. Cook states that his mother was separated and then divorced from his father before he was born, so at no time did he know his real father. He was raised by a stepfather after his mother had remarried until he was about five or six years of age. At this time, he began living in various foster homes, homes for boys, youth homes, etc. Mr. Cook states that his mother did not particularly care about him because he looked so much like his father and states that on occasion she even threatened to kill him. At this time, Mr. Cook was living in the State of California. He spent some time in the McKinley Home for Boys in San Dimas, California; Westside Youth Home in Lancaster, California; the MacLarin Juvenile Hall in El Monte, California; and was also in a foster home in Newhall, California. Mr. Cook describes himself as a very rebellious person, who had difficulty in his relationships with authority figures and who was very argumentative and had difficulty getting along with anyone. He states that he has a half brother, George Bryan Dunn,

who is 14 years of age at the present time; and a sister, Debra Jean Cook, who is 22 years of age. He also has several foster brothers and sisters from his various stays in foster homes. He states that he was very close to his sister, Debra, until he was 15 years of age. Before that time he states that they were companions and friends and would be protective towards one another. At the age of 15, Mr. Cook states that they drew apart from one another and that they have not associated with each other since that time.

Mr. Cook states that his school experience was not good. He was a very poor student--again rebellious and difficult to get along with at school. He states that he had no close friends; and, at the present time, does not feel that he has close friends--the girl he broke up with was his closest personal relationship. He states that because of his attitude and acting-out behaviors, he was suspended in the third grade. He finally quit school and began doing odd jobs. He did state, however, that at the present time he has obtained a G.E.D. He has worked for the Forest Service; however, again, because of his attitude and his inability to get along with others, he was fired.

Mr. Cook states that the only significant medical problem was the fact that he was asthmatic as he was growing up, and he also states that he had a volar plate repair (left thumb) in 1977.

STRENGTHS, ASSETS AND RESOURCES:

Personal: Mr. Cook has never been married and has had very few meaningful relationships with people--males or females. He feels that he has a very low self-concept, admits to his difficulties in relationships, and wants to try to improve this so that he does not have to continue living with other people.

Mr. Cook seems to function at a normal intellectual level. He has no vocational skills other than the work he has done with the Forest Service. His employment has been sporadic. He has no close personal friends or family, but does seem to be close to a Mrs. Barbara Williamson, Box 1815, Salmon, Idaho, whom he looks upon as a foster mother, although in the legal sense he is simply staying with her.

Social: Mr. Cook has very few friends and has difficulty in his relationships with people. His only contacts are a few drinking buddies in Salmon and his foster mother.

Professional: Mr. Cook has been seeing Region VII Mental Health workers, and it was through his working with them that he was referred to State Hospital South.
