This is a readmission of this 20-year-old, white, married male from Blackfoot, Idaho, who was referred by Region VI Mental Health Services. The patient had been hospitalized here from 11 Dec 1981 to 9 Mar 1982 on a Voluntary basis and had left against professional advice to get married. He has not done well since discharge--unable to find work and feeling increasing depression. This culminated in an overdose of 15-20 Mysoline tablets that came from his wife's supply of medications. He was seen at the Bingham Memorial Hospital Emergency Room for acute treatment on 3/16/82 and then referred here for more treatment. The patient apparently told Dr. Abel, Region VI Mental Health worker, that he was still suicidal.

Past History: See in old master chart.

Mental Status: Thin, young, white male in no acute distress, but presently with medication psychomotor retardation and a mildly depressed affect. No evidence of thought disorder. Sensorium is clear. Content of thought: no delusions and describes his overdose as being caused by "nothing to live for--no work out there." Denies marital conflict. Insight only intellectual.

ADMITTING IMPRESSIONS:

- Axis I: Adjustment disorder with depressed mood.
- II: Dependent personality.
- III: No significant illnesses.

Plan: Readmission, no psychoactive medications; further vocational evaluation.

25 Mar 1982 TREATMENT SUMMARY NOTE:

Mr. Cook left the Hospital on an Unauthorized Absence prior to his staffing, so a treatment plan had not been initiated for him, nor had he been involved in any aspect of the previous treatment plan. Mr. Cook was very angry over the fact that he was in the Hospital, over the fact that he had me again as his Primary Therapist, and that he did not feel that the program at the Hospital would help him. His wife would not sign a petition for his commitment. On 22 Mar 1982, we learned that his wife drew out over \$4,000.00 from her savings account in a local bank. We also learned that she had been to the Greyhound Bus Depot a day or so previously during which time she apparently had purchased bus tickets. Mr. Cook jumped over the door watch table on 22 Mar 1982, and at 7:50 pm ran towards town. There was a bus leaving northbound at 8:15. It was felt that after talking with Mr. Cook's wife's brother they had probably both gotten on that bus and had left the area. As a result, Mr. Cook was discharged from his Unauthorized Absence on 23 Mar 1982. He left the Hospital with no medications nor no plans for follow-up.
