1-21-81 - RELEASE SUMMARY AND INDIVIDUAL AFTERCARE TREATMENT PLAN:

IDENTIFYING INFORMATION: Dan is a nineteen year old, single, unemployed, nonresident Caucasian male laborer who entered the hospital by Voluntary Application from Rock Springa, Sweetwater County, Wyoming on December 1, 1980. Prior to his admission he was hospitalized in the Sweetwater County Memorial Hospital from November 28 to his admission as he made a suicide attempt by taking an unknown amount of unknown medications.

PRESENTING PROBLEMS: Dan denied using street drugs or abusing prescription medications. From March 1980 to the present time his drinking habits have been about the same. He would drink to intoxication every chance he got and estimates he would get semi intoxicated three times weekly consuming about three six-packs of beer and a half pint of whiskey on each of the occasions. During a routine investigation to confirm the information gathered from the patient, the following information was obtained. Dan has deep underlying feelings of not being wanted, not being loved, and not being needed. At age three his mother placed him with his grandmother where he resided until age nine when the grandmother passed away. From age nine to age fourteen he lived in the family home with his mother and step father. Life was quite miserable for Dan as it was obvious he was not wanted. At age fourteen he was placed in a youth home and from age fourteen to age nineteen has lived in a variety of youth homes, detention centers and seven different foster homes. He has made many attempts to return to his mother but has always been rejected. It appears that Dan holds a great deal of bitterness and hatred, releasing these feelings when he becomes intoxicated.

PAST HISTORY: Born July 23, 1961 in Chicago, Illinois. He completed 11 grades of formal schooling. Dan joined the Army in January 1980 and in March 1980 did receive an Honorable Discharge under medical conditions. Dan has asthma attacks and was too sickly for military duty. He admits to one charge of DWI and approximately five over night incarcerations as he has been charged with public intoxication and disturbing the peace. Dan and a friend did steal a school bus and totally wrecked it. The school board has dropped all charges and there is no legal problem at this time. Dan is to make restitutions when able to make payments. No set amount are to be made. This was his first psychiatric hospitalization. He estimates he has been hospitalized on eight or ten occasions for alcohol related reasons. He began having asthma attacks at age nine, contracted pneumonia at age eight, and had a tonsillectomy at age seven.

ALLERGIES: None known.

PHYSICAL FINDINGS: Patient was seen by J. B. Bennett M.D. on 12-1-80. Dr. Bennett reports: Status post T & A. Tattoos of the left upper and lower arm and posterior aspect of the right shoulder. Healthy adult male. Asthma by history.

LABORATORY, X-RAY AND OTHER FINDINGS: 12-2-80 hematocrit 50%, hemoglobin 17.7 grams. WBC 8300 with a normal differential. FBS 91 mg %, VDRL nonreactive. 12-2-80 the S00T 1 unit, alkaline phosphatase 43 units which is an elevation. PPD 0 mm in 48 hours. 12-22-80 SCOT 2 units, alkaline phosphatase 53.5 units which is an elevation. 12-2-80 x-ray of the chest showed several calcific hilar nodules, normal heart and lungs. 12-16-80 x-ray of the right fourth toe revealed no fractures. 1-13-81 x-ray of the left knee showed no radiological abnormality. Patient received Tetanus Diptheria Toxoid on 12-2-80

PSYCHIATRIC CONSULTATION: He does not appear a danger to himself or others. He has apparently received MHB. I do not believe he can gain anything significant by further retention. I recommend release as soon as appropriate arrangements can be made.

PSYCHOLOGICAL EVALUATION: The general impression rendered by this nineteen year old single truck driver with above-average ability appears most similar to that of the passive-aggressive personality with antisocial features.

COURSE IN THE HOSPITAL: Dan entered the hospital on December 1, was presented at an Admission Conference on December 5 and was actively included in the Alcohol and Drug Abuse Treatment Program. He was presented at a Review Conference on January 20, 1981. At that Review Conference it was noted Dan was hospitalized 51 days and did abstain from the use of alcohol. However, when the staff was preparing Daniel's personal belongings for his departure they discovered some marijuana, a pipe, a roach clip, and cigarette papers. Apparently Dan was smoking marijuana while in treatment. Dan attended 13 of the possible 17 education classes and only seven sessions of listening lab. He attended a total of nine group counseling sessions, five individual counseling sessions and was called to this counselor's office on five occasions for patient management purposes. Dan attended seven hospital A.A. meetings. In all phases of treatment he could be best described as a semi alert, semi interested observer. Dan did not attend his last two scheduled group counseling sessions and missed his last two individual counseling sessions. He brushed these missed appointments off by saying "I fell asleep and/or I just forgot."

It was further noted he had a lack of vocational skills. Dan was referred to the Division of Vocational Rehabilitation but did not progress far enough into the program to warrant an appointment with the Department of Vocational Rehabilitation Counselor. It was also noted he had an educational deficit. Dan did receive his G.E.D. Certificate on January 8, 1981. Nursing Services reported that he was constantly testing the rules and regulations, created problems for his peers and appeared to be very disinterested in his treatment program.

OTHER MEDICAL INFORMATION: The patient was admitted on 12-1-80 where he had been a patient at the Sweetwater County Memorial Hospital from 11-28-80 to the admission date. He had evidently overdosed on Sleep-Eze, supposedly had taken one half bottle of same. He was treated on the Alcohol and Drug Abuse Treatment Services Program for alcohol dependency and was discharged on 1-21-81 as a Complete Discharge, maximum hospital benefits. He also received Kaopectate for one episode of diarrhea which resolved. Aspirin was given intermittently for headache.

PERSONAL STRENGTHS AND RESOURCE PERSONS:

- A. Personal Strengths: Average intelligence; semi appropriate grooming habits.
- B. Resource Persons: Barbara Williamson, Box 1815, Salmon, Idaho.

FINAL DIAGNOSES: 303.26 Alcohol addiction, mild.
301.81 Passive-aggressive personality with antisocial features.

PROGNOSIS: Extremely poor.

INDIVIDUAL AFTERCARE TREATMENT PLAN:

Problem: Inability to maintain sobriety.

Recommendations: Complete abstinence; attend weekly A.A. meetings; have regular mental health Center contact.

Referrals: None. Dan refused an aftercare treatment plan and refused release of information. He was discharged with no prescriptions, no medications, and was on a regular diet.

DISPOSITION: On January 20, 1981 he was granted a Complete Discharge, maximum hospital
