Petitioner, EDWARD HAROLD SCHAD, by his attorney RHONDA L. REPP, hereby requests this Honorable Court to enter an Order appointing an expert witness, to be compensated by Yavapai County, to assist in his defense. This request is made for the following reasons:

1. Edward Schad was tried and convicted of the murder of Lorimer Leroy Grove, and has been sentenced to death. Through no fault of any party, counsel believes that the trial court did not have the opportunity to consider all of the mitigating factors in passing sentence.

2. Counsel has reason to believe that Edward Schad has not been interviewed completely regarding mitigating factors concerning the abusive relationship between Edward Schad and his abusive father. Counsel's investigator

1 believes that Edward Schad was responsible for his father's incarceration and that,  
2 as a result, Edward Schad was disowned by his family.


3 3. Counsel believes that an expert in the area of mitigation will not  
4 only be helpful to the Court in reaching a fair and just result, but such expert is  
5 essential to a complete presentation of mitigating factors regarding Edward Schad's  
6 actions before and after the killing, as well as other statutory factors.

7 4. Counsel has contacted a mitigation expert to assist with Mr.  
8 Schad's defense. The expert is Holly K. Wake, and her credentials, letters of  
9 recommendation, etc., are attached as Exhibit 1 for the Court's review. Ms. Wake has  
10 significant experience working on capital cases.

12 5. Counsel has asked Ms. Wake for an estimate of the time it would  
13 take her to work on a case such as this. Ms. Wake estimates that it would take over  
14 100 hours of her time, depending on how much information is already available.  
15 Given Ms. Wake's hourly rate of \$30.00 per hour, the Defendant requests an initial  
16 authorization of \$3,000.00 for Ms. Wake's expert services. Additional authorizations  
17 will be sought at such time as the expert nears the \$3,000.00 amount.

19 6. Because this is a capital case, it is in the interest of justice that  
20 the Court enter an Order pursuant to A.R.S. § 13-4013 authorizing the employment  
21 of an expert witness to be paid at the expense of Yavapai County.
