ORDER

Before: SILVERMAN, BYBEE, and CHRISTEN, Circuit Judges.

Under Seal party's motion to stay the district court's August 12, 2013 order pending appeal is denied. *See Hilton v. Braunskill*, 481 U.S. 770, 776 (1987).

Proposed amicus curiae Yahoo! Inc.'s motion for leave to join in amicus curiae LinkedIn Corporation's September 17, 2013 amicus curiae brief is granted.

Proposed amicus curiae Apple Inc.'s motion for leave to file an amicus brief is denied without prejudice to renewal after the filing of Under Seal party's brief.

Appeal Nos. 13-15957 and 13-16731 are consolidated appeals, not cross-appeals. However, the briefing schedule shall mirror the briefing schedule for cross-appeals. *See* Fed. R. App. P. 28.1.

The parties' joint request to have the briefing schedule and redacted versions of the briefs available to the public, contained in the parties' stipulated motion to revise the briefing schedule, is granted in part. Proposed amicus curiae Apple Inc.'s motion for unsealing of the pleadings is granted in part. The court will provide the briefing schedule and redacted versions of the briefs to the public in the Cases of Interest section of the court's public website.

The parties' stipulated motion to revise the briefing schedule in these consolidated appeals is granted. The briefing schedule shall proceed as follows: opening brief from the government parties is due January 10, 2014. Motions for leave to file amicus curiae briefs and the accompanying briefs in support of the government parties are due February 11, 2014. The second brief is due from Under Seal party on February 21, 2014. Motions for leave to file amicus curiae briefs and the accompanying briefs in support of Under Seal party are due on March 25, 2014. The third brief is due from the government parties on April 4, 2014; and the optional reply brief is due from Under Seal party on May 16, 2014.
