It is ordered that these appeals are consolidated.

Oral argument is scheduled for Friday, July 21, 2017, in San Francisco, California. Oral argument shall be limited to 30 minutes per side. Counsel for all Plaintiffs will be required to share the total time allowed for that side and should confer in advance regarding the division of time.

The parties are ordered to submit supplemental briefs that consolidate and supersede their briefing in the various cases. For the purposes of these superseding briefs, Defendant will be treated as the Appellant and Plaintiffs will be treated as the Appellees. All issues should be included in the briefs, including issues raised in any cross-appeals and in the O'Connor Plaintiffs' Amended Request to Remand, Dismiss, and/or Stay Proceedings Pending Further District Court Litigation. Any arguments not included in this briefing may be deemed waived. The briefs must conform to the word and length requirements in Federal Rule of Appellate Procedure 32(a)(7).

The briefing schedule shall proceed as follows: Defendant is to file its opening brief and excerpts of record no later than May 3, 2017; Plaintiffs' answering brief is due on or before May 31, 2017; and any reply brief for Defendant is due on or before June 14, 2017. Counsel for the various Plaintiffs are encouraged but not required to file a single answering brief on behalf of their clients.
