Osawaru Amen Aideyan, a native and citizen of Nigeria, petitions this court for review of the decision of the Board of Immigration Appeals (“BIA”) denying his motion to reopen *sua sponte* its March 5, 2002 decision, which dismissed Aideyan’s appeal from the Immigration Judge’s November 12, 1999 decision. are without jurisdiction to review the BIA's denial of a motion to reopen *sua sponte* under 8 C.F. R. § 3.2(a). Ekimian v. INS, 303 F.3d 1153, 1159 (9th Cir. 2002); see also Minasyan v. Mukasey, 553 F.3d 1224, 1229 (9th Cir. 2009) ("This court does not have jurisdiction to review an alien's claim that the BIA should have exercised its *sua sponte* power' to reopen or reconsider a prior order.") (internal quotation marks and alterations omitted).
