Martin Martinez-Alavarez appeals from the 60-month sentence imposed following his guilty-plea conviction for being a deported alien found in the United States, in violation of 8 U.S.C. § 1326. We have jurisdiction under 28 U.S.C. § 1291, and we affirm.

Martinez-Alvarez contends that the district court procedurally erred by failing to adequately explain the reasons for the sentence and by failing to address Martinez-Alvarez's request for a downward departure. He also contends that his sentence is substantively unreasonable. The district court did not procedurally err, and the below-Guidelines range sentence is substantively reasonable. *See United States v. Carter*, 560 F.3d 1107, 1117-19 (9th Cir. 2009); *United States v. Carty*, 520 F.3d 984, 992-95 (9th Cir. 2008) (en banc).
