Lucio Najera-Corchado appeals from the revocation of supervised release and the 15-month sentence imposed upon revocation. Pursuant to *Anders v. California*, 386 U.S. 738 (1967), Najera-Corchado's counsel has filed a brief

stating that there are no grounds for relief, along with a motion to withdraw as counsel of record. We have considered Najera-Corchado's October 4, 2016, pro se submission. No answering brief has been filed.

Our independent review of the record pursuant to *Penson v. Ohio*, 488 U.S. 75, 80 (1988), discloses no arguable grounds for relief on direct appeal.

Counsel's motion to withdraw is **GRANTED**.
