Ninth Circuit Court of Appeals to Hold Special Sitting at Arizona State University

SAN FRANCISCO – The United States Court of Appeals for the Ninth Circuit will hear oral arguments on September 15 at the Arizona State University, Sandra Day O’Connor College of Law, in Phoenix as part of the court’s weeklong sitting at the Sandra Day O’Connor U.S. Courthouse.

Oral arguments will be held at 10:30 a.m. MST in the W. P. Carey Armstrong Great Hall, ASU Beus Center for Law and Society, 111 E Taylor St. A valid photo ID is required for admittance. Oral arguments will be livestreamed.

The panel will consist of Senior Circuit Judge Andrew D. Hurwitz, Circuit Judge Patrick J. Bumatay and Circuit Judge Roopali H. Desai.

Cases on the docket are:

- Torres-Sanchez v. Garland, in which a citizen of Mexico petitions for review of the Board of Immigration Appeals’ denial of withholding of removal and protection under the Convention Against Torture. Case No. 21-1312
- BBK Tobacco & Foods LLP v. Central Coast Agriculture, Inc., BBK Tobacco & Foods, LLP, appeals and Central Coast Agriculture, Inc., cross-appeals the district court’s summary judgment in an action under the Lanham Act. Case Nos. 22-16190, 22-16281
- Southwest Fair Housing Council v. WG Scottsdale LLC, an appeal from the district court’s judgment after a jury trial in a fair housing action. Case No. 22-16345
- Mark Klamrzynski v. Maricopa County Community College District, in which Mark Klamrzynski appeals the district court’s summary judgment in his employment discrimination action against Maricopa Community College District et al. Case No. 22-16752
