## **Ninth Circuit to Hold Special Sitting at Arizona State University**

SAN FRANCISCO – The U.S. Court of Appeals for the 9th Circuit will hear oral arguments during a special sitting on September 19 at Arizona State University, Sandra Day O'Connor College of Law, in Phoenix as part of the court's weeklong sitting at the Sandra Day O'Connor U.S. Courthouse.

Oral arguments will be held at 9 a.m. MST in the W. P. Carey Armstrong Great Hall, ASU Beus Center for Law and Society, 111 E Taylor St. A valid photo ID is required for admittance. Oral arguments will be livestreamed at <https://www.ca9.uscourts.gov/media/live-oral-arguments/>.

The three-judge panel will consist of Circuit Judges Daniel P. Collins, Salvador Mendoza Jr. and Roopali H. Desai.
