

COVID IMPACTS and UPDATES


- In person hearings are finally back! Only the arguing attorneys and up to 2 guests each, as well as anyone invited to the courthouse to participate in specific meetings or events are permitted in our four courthouses at this time. We are still not open to the general public yet, not clear when that will change.
- At this time, attorneys may still appear by video for hearings without cause or the need to file a motion. We don't know how long that will be the case or what the future will look like.
- ► We have an administrative order in place that requires everyone seeking entry to our courthouses to be fully vaxed and boosted.
- Case filings have gone down significantly, due at least in part to the inability of district courts and agencies to hold trials/hearings over the last two years.
- Our case processing unaffected, backlog is significantly reduced.




Where Do our Appeals Come From?



12 months ending Sept 2021 Filings






AGE OF PENDING CASES

As of Mar 18, 2022







Merit Terminations




Types of Merits Decisions






